REACT (AIM: REAT.L) the leading specialist cleaning, hygiene and decontamination company is pleased to announce a number of recent contract wins.

The largest contract has been awarded to Fidelis to provide contracted maintenance, cleaning and hygiene services within the education sector. It has a total contract value of c.£550,000 during the initial contract term of 3-years, with the option of an additional 3-year extension.

The Group has also won a number of smaller to medium sized contracts in the last few weeks, five of these being in contracted maintenance cleaning and hygiene services, all on 3-year contract terms, with other contract wins securing framework agreements to provide specialist reactive cleaning in both the rail sector and housing associations.

**Shaun Doak, Chief Executive Officer, commented:** "These recent contract awards along with a steadily growing pipeline of opportunities point towards a return to business-as-usual for a number of our customers.
